TERMS OF REFERENCE SUBJECT OF PROCUREMENT: PROVISION OF CAR HIRE/ TRANSPORTATION SERVICES

OBJECTIVES:

To provide transport service to field teams that will be implementing activities under in the districts of Kanungu; Kabale; Kasese; Kabarole; Hoima; Gulu; Nwoya; Arua; Dokolo; Kumi; Serere; Mbale; Tororo; Busia; Bugiri; Jinja; Buikwe; Lyantonde; Mbarara; Nakasongola; and Lira

SCOPE OF WORK: The service shall include drop off and pick up of teams conducting outreach activities within each district. The resulting contract shall be for a period of one year, but may be renewed for a further period not exceeding one year. The number of days that the services will be required will vary from month to month. The vehicle required shall be with a 7seater capacity.

> MARPI does not guarantee that transportation services shall be required every month during the subsistence of the resulting contract and may at its sole discretion obtain services or part of the services under this subject of procurement from any other service provider and when this is done, such shall not be a breach of the contract between MARPI and the Service Provider procured under this procurement process.
